TERMS AND CONDITIONS

1. **Offer:** “Get a \$10 Ultimate Dining E-Promo Card” with ROYALE® Offer.
2. **Sponsor:** Irving Consumer Products Limited.
3. **Fulfillment Company:** The Mobile Experience Company Inc.
4. **Offer Period + Key dates:** To participate in the Offer, a Qualifying Purchase (as defined in Section 6) must be made between August 7, 2019 and October 10, 2019 (the “**Purchase Period**”). The submission period, further described in Section 7, begins at 9:00:00 A.M. Eastern Daylight Time (EDT) on August 7, 2019 and closes 11:59:59 P.M. EDT on October 17, 2019 (the “**Submission Period**”). Participants can access their registration profile and view their status of their submission until 11:59:59 P.M. EDT on November 30, 2019 after which time the Offer Website will no longer be available. Each Ultimate Dining E-Promo Card[‡] (the “**E-Promo Card**”) as further defined below in Section 9) is valid for thirty (30) days from the date the confirmation e-mail was sent. For Quebec residents only, during the Submission process, each participant will select either an E-Promo Card or a \$10.00 ROYALE® coupon (the “**coupon**” and the coupon and E-Promo Card are collectively referred to as the “**Reward**”) as further defined below in Section 9. The \$10.00 ROYALE® coupon expires on December 30, 2019. Graphics on actual Reward may be different than pictured on the Website. The sole determinant of time for the purposes of this Offer, including receipt of a valid submission, will be the Fulfillment computer servers (“**Fulfillment computers**”). Proof of transmission (screenshots or captures, etc.) or attempted transmission does not constitute proof of delivery or receipt by the Fulfillment computers or Fulfillment department.
5. **Eligibility:** You must be (a) a legal resident of Canada and be located in Canada throughout the Submission Period, (b) have reached the age of majority in your province or territory of residence at the time of submission, (c) have a valid e-mail account and access to the Internet. You are not eligible to participate if you are an employee, officer, director, agent or representative of Sponsor, its affiliated and related companies (including, without limitation, its parent, sister and subsidiary companies), the Fulfillment Company, advertising and promotional agencies or other party in any way involved in the development or administration of this Offer, including suppliers of materials or services related to the Offer, or a member of the immediate family or household of any such employee, officer, director, agent or representative. For those who are eligible for a coupon, you must provide a valid mailing address to which the coupon will be sent and only the original manufacturer’s coupon will be accepted at the time of redemption.
6. **Qualifying Purchases:** To participate in the Offer and receive a Reward, you must purchase a minimum of twenty dollars (\$20.00 CAD) before taxes of specially marked packs of participating ROYALE® products **OR** any other participating ROYALE® product (for clarity not specially marked) (the full list of participating ROYALE® product is provided in Schedule “A” hereto) (collectively, “**Participating Products**”) in a single transaction at a participating retailer in Canada during the Purchase Period (collectively, a “**Qualifying Purchase**”).

Email account, internet access and the submission of certain information, including your name, complete mailing address and email address is required to create and complete a “Registration Account” and the uploading of a sales receipt is required to complete a Reward request. Please see Section 22 for more information on our privacy practices.

NOTE: The Offer Websites will be collecting “cookie” information from your browser to identify your computer and provide Sponsor with a record of your visits to the Offer Websites (collectively, “**Usage Data**”). This Usage Data will be used to identify you as a registrant should you return to the Offer Website, unless you have logged out of your Registration Account after your session. **If you logged out after your initial session or cleared your web browser history, you will be required to login into your Registration Account again before you can upload a photograph of your sales receipt. If this is required, the Offer Website will generate and send you a new login email with a new link. - i. Select your preferred language and province or territory of residence and click “Continue”.
- ii. Select “Register and Upload Receipt”.
 - a. **First Time Visitors Must First Create a Registration Account:**
 - i. **Step 1:**
 1. Create a Registration Account by completing the online registration form, which includes inputting your full name, complete mailing address, and e-mail address. Tick the box to indicate your acceptance to the terms and conditions of this Offer.
 2. **Optional Communication:** Tick the box to indicate that you would like to join and receive future promotional communications from ROYALE’s online community (“**Optional Communication**”). **IMPORTANT NOTE: You are not required to opt-in to receive Optional Communications from the Sponsor to participate in the Offer. You can opt-out of receiving Optional Communications from the Sponsor at any time without impacting your participation in this Offer.**
 3. Select “Confirm Details”

- ii. **Step 2:** After selecting “**Confirm Details**”, an onscreen message will appear requesting verification of your personal information. If accurate, select “Confirm & Submit” button. If any field has an error, click on the “Edit” button and correct the field. Once all information is correct, select the “Confirm Details” button.
- iii. **Step 3:** Upon receipt of your Registration information by the Fulfillment computers, you will receive an on-screen message that states “Almost Done! Before you can upload your receipt, you’ll have to confirm your registration. An e-mail will be sent shortly with the subject line: “ROYALE® Stock Up & Dine Out Registration Confirmation Required”. It is the participant’s responsibility to check their in-box, spam, junk, or any other folder that their e-mail provider may push e-mails for your confirmation of Registration e-mail.
- iv. **Step 4:** Open the email from the Offer Website and click on the “Login” button within the email. By clicking the link within the email you agree that the Registration information you have provided is accurate and truthful (a “**Registration**”).

b. Returning visitors – Login:

- ii. Enter your email address and select “Submit”
- iii. If you have not deleted the Offer Website “cookie” on your computer or device and have completed the required Registration steps as noted above, you will be directed to the “Upload Receipt” webpage.
- iv. c. Uploading A Sales Receipt – Requesting a Reward:

- i. **Step 1:** After clicking the link to confirm your Registration information, you will be “Welcomed” to your profile page. You must be logged in to your Registration Account.
- ii. For residents of the Province of Quebec only select either the E-Promo Card or the coupon as your Reward.
- iii. Select “Upload Receipt Photo” button. From your computer, select the location where you saved your photograph or image. Select your saved file and click “open”. The file will then be automatically added to the Offer Website. Remember to make sure your uploaded photograph or image clearly shows your purchase date, purchase total, store name and Participating Product(s) purchased. If your receipt is two sided or too long to fit within one photograph or image, upload two separate images (file names) by selecting “upload another photo” button and repeating the upload process. - iv. Select “Submit”.

- v. **Step 2:** Once you have selected “Submit” an image of your sales receipt will appear. Please ensure your image is clear and all required information is easily visible. If so, select “Confirm and Submit” and if not select “Edit” and take a new photograph or scan of your sales receipt. Repeat the upload process as defined in 7ciii. Selecting “Confirm and Submit” is referred to as a **“Submission”**.
 - vi. **Step 3:** Once your Submission has been received by the Fulfillment computers, you will receive an on-screen message that states “Thank you! - You will receive an e-mail within the next 2 - 7 days that will either, include your Reward or a reason why we could not process your receipt at this time. Your Submission number is xxxxx”. We suggest you write this number down somewhere.
 - vii. In addition to the above on-screen message an email will be sent shortly by the Fulfillment Computers with the subject line: ROYALE® Stock Up & Dine Out - Submission Confirmation. - d. **Processing of Submission:**
- i. Processing of a Submission will take two (2) to seven (7) days from the time the Submission is received by or on behalf of the Fulfillment Company. - e. **Accessing your Registration Account Profile**

E-Promo Card is valid for 30 days from the day of the e-mail was sent. Joe's®, State & Main®, Elephant and Castle® or Pickle Barrel® locations in Canada (the "Participating Restaurants").

- iii. The E-Promo Card value is in Canadian dollars. Expired E-Promo Cards will not be replaced or extended and must be accepted as awarded without representation, warranty or guarantee of any kind. - b. **\$10.00 CAD ROYALE® coupon:** This coupon is offered only to residents of the province of Quebec. The coupon is redeemable within Canada. Each coupon is worth \$10.00 CAD. A qualifying participant will receive an e-mail within two (2) to seven (7) days of a successful Submission being received and processed and will include a mailing date for when the coupon will be mailed to the mailing address as submitted at the time of completing the Registration form. It is the participant's responsibility to check their home mail box. It is anticipated that coupons will be mailed within a 30 day period from the date of the confirmation email.
